

Photographing, Filming and Recording students at Ascot Vale Primary School

Annual Consent Form and Collection Notice 2024

During the school year there are many occasions and events where staff may photograph, film or record students participating in school activities and events. We do this for many reasons, including to celebrate student participation and achievement, showcase learning programs, communicate with our parents, and school community in newsletters, on Compass and on Class Dojo and to document a student's learning journey, camps, excursions, sports events, graduation, etc.

This notice applies to photographs, video or recordings of students that are collected, used, and disclosed by the school. We ask that any parents/carers or other members of our school community photographing, filming or recording students at school events (e.g., concerts, sports events etc) do so in a respectful and safe manner and that any photos, video or recordings ("images" of students are not publicly posted (e.g. to a social media account) without the permission of the relevant parent/carer.

A. Use or disclosure within the school community

<u>Unless you tell us otherwise below,</u> images of your child may be used by our school within the school community, as described below.

Photographs, video, or recordings of students may be used within the school community in any of the following ways:

- in the school's communication, learning and teaching tools (for example, emails, classroom blogs or apps that can only be accessed by students, parents/carers, or school staff with passwords e.g., Compass, Class Dojo etc.)
- for display in school classrooms, on noticeboards, screens, assemblies, etc.
- to support student's health and wellbeing (e.g., photographs of students with medical alerts to assist staff to identify needs)

B. Use or disclosure in publications/locations that are publicly accessible

<u>Unless you tell us otherwise below,</u> photographs, video or recordings of students may also be used in publications that are accessible to the public, including:

- on the school's website, including in the school newsletter which is publicly available on the website
- in school publications, such as the Parent Information Handbook or class made publications intended for wider distribution

Your child may be identified by first name only in these images (or not named at all).

We will notify you individually if we are considering using any images of your child for specific advertising or promotional purposes.

Privacy

Photographs, video, and recordings of a person that may be capable of identifying the person may constitute a collection of 'personal information' under Victorian privacy law. This means that any images of your child taken by the school may constitute a collection of your child's personal information. The school is part of the Department of Education and Training (**the Department**). The Department values the privacy of every person and must comply with the *Privacy and Data Protection Act 2014* (Vic) when collecting and managing all personal information. Ownership and Reproduction

Copyright in the images will be wholly owned by the school. This means that the school may use the images in the ways described in this form without notifying, acknowledging, or compensating you or your child.

Opt Out

Ascot Vale PS understands that parents and carers have the right to withhold permission for our school to use photographs, video, or recordings of your child (apart from circumstances where the school is not required to seek consent – see *our Photographing, Filming and Recording Students Policy*).

If you have read this notice and are comfortable with the school using photos, video or recordings of your child as described above, you do not need to take any further action.

However, if you have decided that you **do not** want images of your child to be collected or used by our school, **please complete the form on page 3** and return it to the Ascot Vale PS office. Please note that it may not be possible for the school to amend past publications or to withdraw images that are already in the public domain.
